Met with David Pullen and toured his facility. This facility consists of two seperate locations. The first location has a metal building with interior pens with attached exterior runs on elevated wire. The second loction a quarter of a mile away has a pole building with metal dog houses on elevated wire. The food is kept in metal hoppers and the water is in metal buckets. There is plenty of shading for the dogs in each of the pens. All of the dogs are very sociable and very friendly. There are 70 AKC adults, 10 Other adults, with 6 AKC puppies, and 10 Other puppies in the kennel at this time. The AKC puppies are too young at this time for DNA. I have reviewed the Ownership and Litter records, which proved to be well kept at this time. This customer uses EZ Kennel software at this time. Pullen, Donald sells most of his dogs by broker, internet, face to face, and mostly by word of mouth and repeat

buyers. This customer specializes in the Chinese Shar-Pei, Pugs, Siberian Huskies, Dachshunds, and Poodles breeds. At this time, this kennel meets the AKC Care and Conditions Policies. Nothing Follows..
